ORDER DENYING STAFF'S MOTION FOR DETERMINATION ON THE PLEADINGS

Issue Date: January 31, 2024 Effective Date: January 31, 2024

An evidentiary hearing on this complaint was scheduled to start on December 6, 2023. However, on December 4, 2023, Staff filed a motion to substitute an evidentiary hearing witness due to the unavailability of one of its witnesses for the hearing. I I-70 Mobile City, Inc. d/b/a I-70 Mobile City Park filed a motion in opposition to Staff's proposed witness substitution.

On December 5, 2023, the Staff filed its *Reply to Respondent's Response to Staff's Motion for Witness Substitution and Motion for Judgment on the Pleadings*. Staff's motion for judgment on the pleadings states that "I-70 has already admitted the truth of Staff's Complaint and no hearing is necessary." Staff then states that I-70 Mobile City Park admitted that it provides water and sewer service to certain tenants and that it billed for

those services based upon usage. Staff states that it is entitled to relief pursuant to Commission Rule 20 CSR 4240-2.117(2), concerning summary disposition.

I-70 Mobile City Park asserts that Staff's motion should be denied because Staff previously argued against I-70 Mobile City Park's motion for summary determination by alleging that there were still facts at issue for the Commission's determination. I-70 Mobile City Park also asserts that Staff's motion is untimely because it was filed at approximately 2:00 p.m. the day before an evidentiary hearing on the merits of Staff's complaint was set to begin.

Commission Rule 4 CSR 240-2.117(2) Determination on the Pleadings, states that the Commission may dispose of all or any part of a case on the pleadings whenever such disposition is not otherwise contrary to law or contrary to the public interest. Similar to summary determination, judgment on the pleadings requires the moving party to show that there are no factual issues.

I-70 Mobile City Park filed previously filed an amended motion for summary determination on September 22, 2023, which the Commission denied on December 7, 2023. Staff's response to I-70 Mobile City Park's motion states that genuine issues of material fact exist. Staff goes on to state that, "Multiple, disputed facts, known and unknown remain to be presented to the Commission for interpretation." Staff's motion for judgment on the pleadings contradicts its own assertion that there are issues of material fact that require the Commission's interpretation.

The Commission will deny Staff's motion.

THE COMMISSION ORDERS THAT:

1. Staff's motion for judgment on the pleadings is denied.

2. This order shall be effective when issued.
