ORDER RECOGNIZING PARTIES

On November 3, 2023, Evergy Metro, Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc., d/b/a Evergy Missouri West (collectively referred to as “Evergy”) filed a motion to open new dockets for the filing of their 2024 Triennial Integrated Resource Plans. Commission Rule 20 CSR 4240-22.020(56) defines “Stakeholder Group” as including any entity granted intervention in a prior Chapter 22 proceeding of the electric utility. That regulation also provides that such entities are to be parties to any subsequent related Chapter 22 proceeding of the electric utility without the necessity of applying to intervene in the subsequent case. The Commission will therefore recognize that the parties to File Nos. EO-2023-0212 and EO-2023-0213, Evergy Missouri Metro and Evergy Missouri West’s most recent annual IRP update filings are parties to this case.

THE COMMISSION ORDERS THAT:

1. The parties to File Nos. EO-2023-0212 and EO-2023-0213 are recognized as parties to this case.

2. This order shall be effective when issued.
