The Commission opened this file on February 20, 2019, to facilitate discussions regarding Missouri-American Water Company's (MAWC's) Lead Service Line Replacement Program (LSLR Program). This working case has served as a repository for MAWC's annual reports on the LSLR Program.

As part of the first Stipulation and Agreement filed by the parties in MAWC's most recent rate case, File No. WR-2022-0303, MAWC agreed to file bi-annually a lead service line report in that case. The parties to the first Stipulation and Agreement also agreed to support closing this working case. The Commission approved the first Stipulation and Agreement in File No. WR-2022-0303 on May 3, 2023.

Since the objectives of opening File No. WW-2019-0242 are now being met through File No. WR-2022-0303, MAWC filed a motion to close this file. MAWC stated in its motion that counsel for the Staff of the Commission, Midwest Energy Consumers Group, the City of St. Joseph, and the Office of the Public Counsel have reviewed this pleading and agree that this case file should be closed. No responses to MAWC's motion were received. The Commission will close this file.
