ORDER DIRECTING NOTICE, SETTING INTERVENTION DEADLINE, AND DIRECTING STAFF RECOMMENDATION

On February 2, 2024, Ameren Transmission Company of Illinois (ATXI) filed an application with the Commission seeking an order granting a Certificate of Convenience and Necessity (CCN) pursuant to Section 393.170.1, RSMo. The CCN would authorize ATXI to construct, install, own, operate, maintain, and otherwise control a new 345 kV switchyard and associated facilities (known as "Fabius Switchyard") in Knox County, Missouri. ATXI requests the Commission grant it a CCN to be effective on or before May 31, 2024.

The Commission will provide notice of the application to the general public and interested parties and set a deadline for intervention requests. Further, the Staff of the Commission (Staff) will be directed to file a recommendation regarding ATXI's application.

THE COMMISSION ORDERS THAT:

- The Commission's Data Center shall provide a copy of this order to the County Commission of Knox County, Missouri.
- 2. The Commission's Public Policy and Outreach Department shall make notice of this order available to the media serving Knox County, Missouri.

- 3. Any person wishing to intervene in this matter shall file an application to intervene no later than March 6, 2024. The application shall be filed in the Commission's Electronic Filing and Information System (EFIS) or with the Secretary of the Commission.
- 4. Staff shall file a recommendation regarding ATXI's application, or a request for additional time in which to file its recommendation, no later than March 19, 2024.
 - 5. This order shall be effective when issued.
