Comes Now Dogwood Energy, LLC (“Dogwood”) pursuant to 20 CSR 4240-2.116(3) and the Commission’s general authority and for its Motion to Withdraw states to the Commission:

1. On November 3, 2023, Evergy Metro, Inc. and Evergy Missouri West, Inc. (herein collectively “Evergy”) filed motions to open new dockets for the filing of their 2024 Triennial Integrated Resource Plans.
2. On February 2, 2024 the Commission issued its Order Recognizing Parties which recognized Dogwood as a party to these proceedings based on its status as a party to Evergy’s prior IRP proceedings.
3. Dogwood does not wish to devote resources to these proceedings and, therefore, seeks to withdraw as a party.

WHEREFORE, Dogwood asks the Commission to allow it to withdraw as a party to these proceedings.
