**ORDER DISMISSING CASE**

Issue Date: February 7, 2024 Effective Date: March 8, 2024

On October 16, 2023, Life Center Church filed a formal complaint pursuant to rule 20 CSR 4240-2.070 against Spire Missouri Inc. d/b/a Spire. The complaint is signed by Elijah H. Hankerson, III.

Commission Rule 20 CSR 4240-2.040(5), specifically addressing practice before the Commission, states:

A natural person may represent himself or herself. Such practice is strictly limited to the appearance of a natural person on his or her own behalf and shall not be made for any other person or entity.

The Commission issued a Notice of Deficiency on October 16, 2023, informing the Complainant that counsel must represent Life Center Church in this complaint.

Commission Rule 20 CSR 4240-2.116(2) states that the Commission may dismiss cases for lack of prosecution if no action has occurred for 90 days, and no party has filed a

pleading requesting a continuance. More than 90 days has elapsed since Complainant filed this complaint, and Complainant has not filed any further pleadings. Thus, the Commission will dismiss the complaint.

**THE COMMISSION ORDERS THAT:**

1. The complaint is dismissed without prejudice.
2. This order shall be effective on March 8, 2024.
