On September 28, 2023, Complainants Dranel J. Clark and Aquilla Canada filed a complaint with the Commission against Union Electric Company d/b/a Ameren Missouri. On November 21, 2023, Ameren Missouri filed its *Answer and Affirmative Defenses*. On December 20, 2023, Staff filed its *Staff Report*.

On February 9, 2024, a procedural conference was held in which the parties were asked to collaborate and file a proposed procedural schedule on which all parties agree. The Commission will formalize that direction to the parties and set a deadline.

THE COMMISSION ORDERS THAT:

1. No later than February 23, 2024, Staff shall file, on behalf of all of the parties, a joint proposed procedural schedule.

2. This order shall be effective when issued.
