ORDER MODIFYING EFFECTIVE DATE

On December 14, 2023, IM Telecom, LLC d/b/a Infiniti Mobile requested designation as an Eligible Telecommunications Carrier (ETC) to be eligible to provide Lifeline service. On January 31, 2024, the Commission granted Infiniti Mobile's request in its *Order Granting Designation as an Eligible Telecommunications Carrier* (Order). Pertinent here, the Commission's Order granting the designation was issued with a 30-day effective date of March 1, 2024.

On February 6, 2024, Infiniti Mobile filed a motion seeking to modify the 30-day effective date to an effective date of February 10, 2024.

The Commission allowed time for responses to Infiniti Mobile's motion, but no responses or objections were received. The Commission finds the request to modify the effective date of its Order to less than 30 days to be reasonable, and will grant it.

THE COMMISSION ORDERS THAT:

1. The effective date of the Commission's *Order Granting Designation as an Eligible Telecommunications Carrier* is modified from March 1, 2024, to February 10, 2024.
2. This order shall be effective when issued.
