On January 25, 2024, Union Electric Company d/b/a Ameren Missouri and the Staff of the Commission (Staff) filed a *Joint Motion to Suspend Procedural Schedule* that stated that the two parties had reached agreement on the terms of a settlement resolving all issues in this matter and would be filing a stipulation and agreement formalizing the terms of the settlement within days of the motion. The Commission granted the motion on January 25, 2024, and suspended the procedural schedule.

The Commission will now direct Staff to file a report on the status of the stipulation and agreement.

1. No later than February 27, 2024, Staff shall file a report on the status of the stipulation and agreement with Ameren Missouri.
