ORDER DIRECTING STAFF FILE A MONTHLY STATUS REPORT

On December 20, 2023, the Commission directed its Staff (Staff) to provide additional information about noncompliant well agreements that the Missouri Department of Natural Resources (DNR) drafted for Leon Travis Blevins' water systems. At the time of the evidentiary hearing on Staff's request to pursue a receivership, the noncompliant well agreements had been drafted and were under DNR internal review prior to being presented to Blevins.

On January 8, 2024, Staff filed a status report informing the Commission that on December 28, 2023, DNR issued a *Notice and Order to Abate Violations and Pay Administrative Penalties concerning the Misty Mountain Public Water System*. That administrative order requires that Blevins take corrective actions. Some of DNR's required actions could take up to 240 days for Blevins to complete.

The Commission recognizes that DNR is continuing to engage with Blevins to bring his water systems into DNR compliance. However, the Commission also has an interest in Blevins providing safe and adequate service. If the Commission pursues a receivership it is possible that Blevins will not have time to complete DNR's corrective actions prior to a receiver taking over the water systems.

Therefore, the Commission is directing its Staff to provide monthly status reports on Blevins' progress, or lack thereof, in completing DNR's corrective actions. Staff shall also immediately inform the Commission if it becomes aware of any significant changes in Blevins' engagement with DNR or of any significant changes with his water systems.

THE COMMISSION ORDERS THAT:

1. Staff will file a monthly status report beginning March 7, 2024, concerning Blevins' engagement with DNR.

2. Staff shall immediately inform the Commission if Staff becomes aware of significant changes in Blevins' engagement with DNR or of any significant changes with his water systems.

3. This order is effective when issued.
