## ORDER DIRECTING LIBERTY TO FILE WORKPAPERS

The Commission held a procedural conference on December 19, 2023, to better understand The Empire District Electric Company d/b/a Liberty and the Office of the Public Counsel's disagreement about PPA replacement values and the Market Price Protection Mechanism (MPPM). The Commission is still considering how to best address this issue.

At the conference Liberty stated that is was willing to file the workpapers for its calculations. Therefore, the Commission will direct Liberty to file those workpapers.

### THE COMMISSION ORDERS THAT:

1. Liberty shall file the workpapers containing the calculations for the MPPM and PPA replacement values no later than February 19, 2024.
2. This order is effective when issued.
