WATER SUPPLY FACILITY OPERATIONS AGREEMENT-CONTRACT OPERATOR

This agreement, effective this 25th day of August 2022, by and between the Facility, Rolling Hills Public Water System, Leon Travis Blevins, Owner, 15405 Texas Road, St. Robert, Pulaski County, Missouri 65584 MO3036362 hereinafter called the "supply", and Lori A. Jean, hereinafter called the "Chief Operator".

This supply agrees to employ the Chief Operator as the "person in responsible charge" of the supply's water treatment and/or distribution system. *It is the responsibility of the supply to employ a Chief Operator possessing a valid certificate equal to or greater than the classification of the system.* This contract requires the chief operator to perform on site duties as follows:

1. The minimum frequency of routine visits to the treatment facility or distribution system shall be one time per month at a flat rate of \$150.00 per month for routine services. The Chief Operator will email a monthly invoice to the supply after routine samples are collected. A late notice will be sent 21 days after the initial invoice, if payment has not been made. All DNR samples, routine, repeat, and/or special samples such as VOC's, IOC's, Nitrates and others will be collected as requested by the DNR at no additional cost to the facility.
2. Boil Orders and all other non-routine issues will be subject to additional fees. My current hourly onsite rate is \$20 per hour and round-trip mileage is billed according to the federal rate which is currently .625 per mile.
3. The chief operator duties and responsibilities are to keep the supply in compliance with all DNR regulations by communicating all issues and needs of the system to the Administrator in charge. Any parts or supplies paid for by the Chief Operator will be reimbursed by the Supply after the Chief Operator provides a receipt to the Supply.
4. The certification level required by the Missouri DNR for this system is DS I level. The level of certification held by Lori Jean, Certified Operator #9729, is currently: DS II & Treatment Class C in good standing with the DNR. Current Certification expires in 2025.
5. In the event of an unplanned loss of pressure, the supply will contact the chief operator immediately.
6. In the event of a planned repair, the supply will contact the chief operator at least 24 hours before the planned event.
7. This agreement shall be for an unspecified length of time, either party has the right to terminate this agreement with 30 day written notice.
8. NOTE: Anything not specified in the agreement with the chief operator as operator duties and responsibilities shall be the responsibility of the system owners/managers of the supply.


