ORDER APPROVING COMPLIANCE TARIFF SHEETS

Effective Date: February 28, 2024

On December 21, 2023, the Commission issued its *Order Approving Acquisition of Assets and Granting A Certificate Of Convenience And Necessity* (Order) granting Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) a certificate of convenience and necessity (CCN) to provide sewer service in the area formerly served by Country Life Acres in Jefferson County, Missouri.

On January 29, 2024, Confluence Rivers filed tariff sheets purporting to be in compliance with the Commission’s Order. Those tariff sheets were assigned Tracking No. JS-2024-0106 and have an effective date of February 28, 2024. Confluence Rivers subsequently filed substitute tariff sheets on January 30, 2024.

On February 13, 2024, the Staff of the Commission (Staff) filed its recommendation, taking into account all substituted tariff sheets and affirming that the tariff sheets comply with the Order. Upon reviewing the pleadings, the Commission finds Confluence Rivers’ proposed tariff sheets comply with the Commission’s Order and will approve them. To enable the tariff sheets to become effective on the date requested by

the Company, the Commission finds it reasonable to make this order effective in less than 30 days.

THE COMMISSION ORDERS THAT:

1. The proposed tariff sheets filed on January 29, 2024, substituted on January 30, 2024, and assigned Tracking No. JS-2024-0106 are approved to become effective February 28, 2024. The approved tariff sheets are as follows:
