ORDER DIRECTING APPLICANT TO SHOW CAUSE WHY APPLICATION SHOULD NOT BE DISMISSED

On February 1, 2024, the Commission issued an order setting a prehearing conference in this matter for February 15, 2024, at 11:30 a.m., to be conducted via WebEx telephone and video conference. Counsel for The Empire Electric Company d/b/a Liberty, New-Mac Electric Cooperative, Inc., and Staff of the Commission appeared for the prehearing conference at the scheduled date and time. Applicant Trevor Frerer did not appear.

Per Commission Rule 20 CSR 4240-2.090(5), "Failure to appear at a prehearing conference without previously having secured a continuance shall constitute grounds for dismissal of the party or the party's complaint, application or other action unless good cause for the failure to appear is shown."

The Commission will order Mr. Frerer to file a pleading showing cause as to why his application should not be dismissed for failure to appear at the prehearing conference.

THE COMMISSION ORDERS THAT:

1. Applicant Trevor Frerer shall file a pleading no later than March 7, 2024, showing cause why his application for a change of electric supplier should not be dismissed for failure to appear at a prehearing conference.

2. This order is effective when issued.
