On December 12, 2023, the Staff of the Commission (Staff) filed its recommendation regarding Summit Natural Gas of Missouri, Inc.'s (SNGMO's) Actual Cost Adjustment filing. Staff requested that the Commission order SNGMO to respond.

SNGMO responded on January 31, 2024, which included an objection to the calculation of interest for the Storm Uri balance, and a further statement indicating a discussion with Staff would follow regarding resolving any disagreement.

The Commission will direct the parties to provide a status report.

1. No later than February 22, 2024, the parties, via a filing from Staff, shall file a status report.
2. This order shall be effective when issued.
