ORDER DIRECTING STAFF REVIEW

On January 18, 2024, the Commission issued its *Report and Order* (Order) regarding a general rate increase for the Raytown Water Company (RWC or “the Company”). On February 16, 2024, RWC filed tariff sheets purporting to be in compliance with the Commission’s Order. Those tariff sheets were assigned Tracking No. JW-2024-0113 and have an effective date of March 17, 2024.

RWC requested expedited treatment of the tariff sheets; that they become effective on March 4, 2024, or as soon thereafter as is practicable.

The Commission will direct its Staff to review the tariff sheets and provide its recommendation. The Commission will also set a time for other responses.

THE COMMISSION ORDERS THAT:

1. No later than February 23, 2024, Staff shall file a recommendation as directed in the body of this order or a statement of when it expects to file its recommendation.

2. No other party is required to respond, but any party that wishes to respond to the tariff sheet filings or the request for expedited treatment shall do so no later than February 23, 2024.

3. This order shall be effective when issued.
