## ORDER DIRECTING STAFF TO FILE RECOMMENDATION

On February 15, 2024, Evergy Metro, Inc. d/b/a Evergy Missouri Metro, hereinafter Evergy, filed an application requesting financing authorization in the amount of \$300 million through December 21, 2024, subject to all of the terms and conditions approved by the Commission.

Evergy also requests expedited treatment such that the Commission issues a final order in this matter no later than March 15, 2024. The Commission will direct the Staff of the Commission (Staff) to file a recommendation regarding Evergy's application.

### THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation, or alternative pleading regarding Evergy's application requesting financing authorization in the amount of \$300 million no later than February 26, 2024.
2. This order shall be effective when issued.
