Declaration of Truth In the form of an Affidavit

on The United States of America (1787)
on The Missouri Republic (1821)
on St. Louis county } ss.

Whereas i, Kelvin Dewan Dudley, an Honorable man and Private American National on the Land of the Missouri Republic, being of sound mind and of majority age, hereby deposes and declares on his own firsthand knowledge and under him unlimited commercial liability as one of the People of the Posterity of "We the People", without the corporate or municipal UNITED STATES, that the following statements of fact are true, correct, and complete to the very best of her knowledge, and not designed to mislead in any way:

- 1) That your Declarant, Kelvin Dewan of the Dudley family, was born on the land of the Missouri Republic on the land known as St. Louis on the 16 day of July in the year 1966 C.E. to Cleola Dudley and John Dudley — both Private American State Nationals with fully protected Constitutional Rights, and that by virtue of this birth and [2 Stat 153, c.28, ss.1, Revised Statute 2165], Declarant also became a native Private American National on The Missouri Republic and therefore CANNOT be any 14th Amendment juristic or artificial person nor a "Public U.S. citizen" subject to the will of CONGRESS, nor the legislative Acts of any of the Corporate or Municipal United States Franchises such as STATE OF MISSOURI, et.al; and
