## **ORDER GRANTING EXTENSION OF TIME**

On May 19, 2023, Spire Missouri Inc. d/b/a Spire filed an application requesting a variance from the Resale Provision of its Tariff Rules and Regulations. The Staff of the Commission (Staff) was directed to file a recommendation. Staff requested authority to seek a formal interpretation of the federal rule from the Pipeline and Hazardous Materials Safety Administration (PHMSA), and was directed to file a status report no later than February 20, 2024. In a separate order, Staff was directed to file its recommendation no later than March 13, 2024.

On February 16, 2024, Staff filed its status report on its response from PHMSA, and also requested an extension to file its recommendation to April 30, 2024. Staff is awaiting a response from PHMSA to complete its recommendation, and offers to file a status report or recommendation by April 30, 2024. The Commission finds this request reasonable and will grant it.

## THE COMMISSION ORDERS THAT:

1. Staff shall submit its recommendation or status report no later than April 30, 2024.

2. This order shall be effective when issued.
