ORDER SHORTENING TIME FOR RESPONSES

On October 13, 2023, Liberty Utilities (Missouri Water) LLC d/b/a Liberty submitted an application requesting authorization to issue long-term debt in the amount up to \$30 million. On December 21, 2024, the Staff of the Commission (Staff) filed its Recommendation which included proposed conditions. On January 9, 2024, Liberty responded with an objection to one of the conditions.

The parties, Liberty, Staff, and the Office of Public Counsel, discussed Liberty's concerns. As a result, Staff filed *Staff's Amended Conditions*. That filing withdrew Staff's previous proposed conditions, and recommended new conditions.

The Commission will shorten the time for responses.

THE COMMISSION ORDERS THAT:

1. No party is required to respond, but any response to *Staff's Amended Conditions* must be filed no later than February 23, 2024.

2. This order shall be effective when issued.
