**ORDER EXTENDING DEADLINE FOR
FILING OF A STIPULATION AND AGREEMENT**

On February 13, 2024, the Office of the Public Counsel (OPC), the Staff of the Commission (Staff), and Evergy Missouri West (Evergy) jointly filed a *Motion to Suspend the Procedural Schedule and Motion for Expedited Treatment*. The motion stated that the movants had reached an agreement in principle to settle this case and that they are currently in the process of formalizing the agreement into a stipulation and agreement to be filed with the Commission. At the request of the movants, the Commission suspended the procedural schedule and set a February 22, 2024, deadline to file a stipulation and agreement or a status report.

On February 22, 2024, Evergy filed a *Status Report*, in which Staff and OPC concurred, that requested an extension to February 26, 2024, in which to file a stipulation and agreement.

The Commission will grant the request, but extend the deadline beyond the date requested.

THE COMMISSION ORDERS THAT:

1. OPC, Staff, and Evergy shall jointly file a stipulation and agreement no later than February 29, 2024.

2. This order is effective when issued.

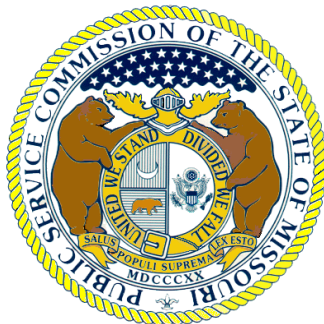
