Although Level 3 is a party to the Agreement, it did not join in the application. Because Level 3 is a necessary party to a full and fair adjudication of this matter, the Commission will add Level 3 as a party to this case.

The Act provides that the Agreement must be approved unless the state commission finds that the Agreement discriminates against a telecommunications carrier not a party to the Agreement, or that implementation of the Agreement is not consistent with the public interest, convenience, and necessity.² Section 252(e)(4) of the Act provides that if the Commission has not acted to approve or reject an Agreement within 90 days after submission, the Agreement shall be deemed approved. That date is May 23, 2024.

The Commission finds that proper persons shall be allowed 15 days from the issuance of this order to file a motion for hearing. The Commission also finds that notice of this application shall be sent to all interexchange and local exchange telecommunications companies. The Staff of the Commission (Staff) will be directed to provide recommendation.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall send a copy of this order to all interexchange and local exchange telecommunications companies.
2. Level 3 is made a party to this case.
3. Any party wishing to intervene or request a hearing shall do so by filing a pleading no later than March 11, 2024.

4. Staff shall file a recommendation advising either approval or rejection of this Agreement and giving the reasons therefor, or a status report regarding when Staff anticipates filing its recommendation, no later than March 26, 2024.

5. This order shall be effective when issued.
