1	Q.	Why is Staff updating the in-service analysis?	
2	А.	Staff requested through follow up data requests, and Ameren Missouri provided,	
3	additional information and verification from Ameren Missouri regarding the satisfaction of		
4	term 2.c. of the jointly submitted in-service criteria.		
5	Q.	What does term 2.c. of the in-service criteria require?	
6	А.	Term 2.c. requires each item on the MCC to have been satisfied and proof that	
7	the turbine is ready to commence commissioning. <sup>1</sup>		
8	Q.	What additional information did Ameren Missouri provide?	
9	А.	Ameren Missouri's response to Staff Data Request No. 0767 included a	
10	list of MCC items that either remained open or had been completed and were considered closed.		
11	Ameren Missouri's initial response to Staff's follow up Data Request No. 0767.1 indicated that		
12	all but one of the MCC items were resolved as of August 30, 2021. The MCC item that		
13	remained open as of September 1, 2021 was a damaged switch with an expected resolution date		
14	of September 17, 2021. Ameren Missouri provided a supplemental response to Staff Data		
15	Request No. 0767.1 on September 20, 2021, which indicated that the final open MCC item was		
16	resolved on September 16, 2021.		
17	Q.	What is Staff's updated position regarding Ameren Missouri's fulfillment of the	
18	jointly submitte	ed in-service criteria?	
19	A. 1	Based on Staff's analysis, High Prairie has met the in-service criteria as of	
20	September 16, 2021. Since Staff initially developed its revenue requirement as though the High		

<sup>&</sup>lt;sup>1</sup> Commissioning is the process by which a developer tests the operability and condition of mechanical, electrical, and safety components for each wind turbine prior to placing the turbine into operation to produce power. The jointly filed in-service criteria requires the completion of a Commissioning Completion Certificate for each turbine.

Prairie project was in-service, an adjustment based upon failure to meet the in-service
 requirements is unnecessary at this time.

3 Q. Do any other Staff members intend to file testimony related to the High Prairie
4 Wind Farm?

A. Yes, Staff witnesses Claire Eubanks and Lisa Ferguson will provide testimony
regarding the curtailment of the wind turbines.
