- 2. The hearing shall begin at 9:00 a.m. and will be conducted online via Cisco WebEx video and teleconference. The link, access telephone numbers, and access code to participate in the hearing will be emailed to all parties.  - 3. The parties shall comply with the following procedural requirements:
 - a. Although not all parties may agree upon how each issue should be described or on whether a listed issue is in fact a proper issue in this case, the parties shall agree upon and file a list of the issues to be heard, the order in which witnesses will be called, and the order of cross-examination for each witness. The Commission will view any issue not contained in this list of issues as not requiring resolution by the Commission.
 - c. All pleadings, briefs, and amendments shall be filed in accordance with Commission Rule 20 CSR 4240-2.080.
 - d. Exhibit numbers are assigned in the following manner:

- e. Each party shall prepare a list of its pre-filed, pre-marked exhibits and file a copy of that list in the Commission's Electronic Filing and Information System (EFIS).
