On February 15, 2024, the parties filed a proposed procedural schedule. The Commission finds the proposed schedule appropriate, and will adopt it, with slight modifications. To ensure that discovery disputes can be promptly resolved, the Commission will exercise its authority under Section 386.240, RSMo 2016, by delegating its authority to the presiding regulatory law judge to rule on discovery disputes and to rule on all motions to compel.
