On February 28, 2024, TruConnect Communications, Inc. d/b/a TruConnect filed its application for expansion of its designation as a wireless Eligible Telecommunications Carrier. The Commission will direct its Data Center to issue notice of the application, set a deadline for requests to intervene, and direct the Staff of the Commission to file a recommendation.

THE COMMISSION ORDERS THAT:

1. The Commission’s Data Center shall send notice of this application to all local exchange carriers certificated to provide service in Missouri.
2. Requests to intervene shall be filed with the Commission no later than March 15, 2024.
3. The Staff of the Commission shall file a recommendation no later than April 15, 2024.

4. This order shall be effective when issued.
