On January 31, 2024, the Commission issued its *Order Approving Acquisition of Assets and Granting a Certificate of Convenience and Necessity* (Order) granting Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) a certificate of convenience and necessity (CCN) regarding North Oak Sewer District, Inc. (North Oak) in Warren County, Missouri.

On February 28, 2024, Confluence Rivers filed tariff sheets purporting to be in compliance with the Commission’s Order. Those tariff sheets were assigned Tracking No. JS-2024-0117 and have a proposed effective date of March 29, 2024.

The Commission will direct its Staff to review the tariff sheets and provide its recommendation. The Commission will also set a time for other responses.

THE COMMISSION ORDERS THAT:

1. No later than March 18, 2024, Staff shall file a recommendation as directed in the body of this order or a statement of when it expects to file its recommendation.
2. No other party is required to respond, but any party that wishes to respond to the tariff filings shall do so no later than March 18, 2024.

3. This order shall be effective when issued.
