ORDER DIRECTING NOTICE, SETTING DEADLINE TO INTERVENE, AND DIRECTING STAFF TO FILE A RECOMMENDATION

On March 1, 2024, Liberty Utilities (Midstates Natural Gas) Corp d/b/a Liberty (Liberty) filed tariff sheets (Tracking No. JG-2024-0122) to change Liberty's weather normalization adjustment rider (WNAR) rates for gas service. The tariff sheets have a proposed effective date of April 1, 2024.

The Commission will direct notice of Liberty's WNAR filing. The Commission will also direct the Staff of the Commission (Staff) to file a recommendation regarding Liberty's tariff sheets and will allow other parties an opportunity to respond.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall provide a copy of this order to all parties to Liberty's last general rate case – File No. GR-2024-0106.
2. Staff shall file its recommendation regarding Vicinity's revised tariff sheets no later than March 13, 2024.
3. Any other responses shall be filed no later than March 14, 2024.

4. This order shall be effective when issued.
