On January 23, 2024, the Staff of the Commission filed a Notice of Letter of Inquiry. In that notice, Staff stated that the Federal Communications Commission sent Aristotle a Letter of Inquiry (LOI). Staff requests the Commission order Aristotle to file a copy of the LOI, as well as to file updates to the LOI or other investigations related to Aristotle's requirements as an Eligible Telecommunications Carrier.

Commission Rule 20 CSR 4240-2.080(13) allows parties ten days to respond to pleadings unless otherwise ordered by the Commission. The Commission issued no order to the contrary of that rule, more than ten days have elapsed since Staff's Notice, and no party has responded.

The Commission takes up Staff's request unopposed, finds it reasonable, and will grant it.

THE COMMISSION ORDERS THAT:

1. Aristotle shall respond as ordered above no later than April 5, 2024.

2. This order is effective when issued.
