ORDER CANCELING AUTHORITY

Issue Date: March 6, 2024

Effective Date: April 8, 2024

On December 28, 2023, the Staff of the Commission (Staff) filed a motion asking the Commission to cancel the registration of Google Voice Inc. (Company) to provide interconnected voice over internet protocol (IVoIP). The Commission granted Company registration to provide IVoIP service in File No. DA-2020-0106.

Staff's motion states that Company filed a letter on December 10, 2023 that it no longer wished to provide IVoIP services in Missouri. Staff recommended that the Commission cancel the Company's registration.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected." The Commission issued notice and allowed time to request a hearing. The Company has not responded.

Based on Staff's motion, the Commission finds that the registration granted to Company shall be canceled.

THE COMMISSION ORDERS THAT:

1. The registration to provide interconnected voice over internet protocol service authority granted to Company in File No. DA-2020-0106 is canceled.
2. This order shall become effective on April 8, 2024.
3. This case may be closed on April 9, 2024.
