ORDER GRANTING PROTECTIVE ORDER

On January 25, 2024, Union Electric Company d/b/a Ameren Missouri filed a Motion for Protective Order pursuant to Commission Rule 20 CSR 4240-2.135(4). Ameren Missouri states that there is information in this case that should not be available to employees of non-state agencies not covered by confidentiality requirements. Thus, Ameren Missouri asks the Commission to grant a protective order to allow Ameren Missouri to designate proper material as "Highly Confidential".

Commission Rule 20 CSR 4240-2.080(13) allows parties ten days to respond to pleadings unless otherwise ordered by the Commission. The Commission issued no order to the contrary, ten days have elapsed since Ameren Missouri filed the motion, and no party has objected.

The Commission finds the motion reasonable, and will grant it.

THE COMMISSION ORDERS THAT:

1. The Motion for Protective Order is granted.
2. Resource cost information contained in Appendix C to Ameren Missouri's application filed on March 27, 2023, any related workpapers, and any such resource cost

information that may later be sought via discovery is Highly Confidential.

3. Any cost information in Appendix C should not be shared with any employees of a non-state party, or if it has been shared, such employees should promptly return all such information to the party's attorney of record.

4. The parties shall use the Non-Disclosure Agreement forms marked as Exhibits A and B to the Motion for Protective Order.

5. This order shall be effective when issued.
