This file was held open pending a resolution of File No. EF-2022-0155, Evergy Missouri West's requests to securitize costs from the same February 2021 cold weather event for which this file seeks an accounting authority order. Given that the Commission granted securitization of those costs and Securitized Utility Tariff Bonds have been issued, the Commission questions the appropriateness of maintaining this docket.

Accordingly, the Commission will order the parties to file a response addressing whether this file should be closed and the application dismissed.

1. No later than March 15, 2024, the parties shall file a response addressing whether this file should be closed and the application dismissed.
