ORDER ESTABLISHING TIME TO RESPOND TO MOTION

On August 12, 2019, the Staff of the Public Service Commission filed a motion requesting that the Commission cancel Mitel Cloud Services, Inc.'s certificates of service authority to provide interexchange and competitive local exchange telecommunication service in the State of Missouri. The Commission granted Mitel Cloud Services certificates of service authority to provide competitive local and interexchange telecommunication service in the State of Missouri in File Number CA-2004-0485. The company has two applicable tariffs that are to be canceled.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹ Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission may cancel the certificate based on Staff's motion.

The Commission finds that proper persons shall be allowed 10 days from the issuance of this order to file a motion for hearing.
