## ORDER DIRECTING FILING OF JOINT PROPOSED PROCEDURAL SCHEDULE

On November 7, 2023, Trevor King filed an application with the Commission requesting a change of electric supplier from Eversource Missouri West, Inc. d/b/a Eversource Missouri West (Eversource) to Osage Valley Electric Cooperative (Osage Valley). On November 13, 2024, and December 1, 2024, Matthew Gibreal and Tyler Watts, respectively, each also filed an application with the Commission requesting a change of electric supplier from Eversource to Osage Valley. The Commission assigned separate file numbers for the three applications.

Eversource and Osage Valley filed responses to the applications in the three files. On January 24, 2024, the Commission consolidated the three files into a single file.

On February 16, 2024, the Staff of the Commission (Staff) filed its recommendation that the Commission grant the applications.

Having received the applications, the responses of the current and requested electric suppliers, and Staff's recommendation, this matter is ready to proceed to hearing. The Commission will direct the parties to collaborate and file a joint proposed procedural schedule.

**THE COMMISSION ORDERS THAT:**

1. The parties shall collaborate on a joint proposed procedural schedule to be filed by Staff no later than March 22, 2024.
2. This order is effective when issued.
