### Motion for Injunction

Complainant files this Motion with the Missouri Public Service Commission to seek that the Respondent is held fully responsible for their fraudulent actions and submitting a fraudulent and altered document to the Missouri Public Service Commission, Commissioners, Regulatory Judge in which decided a crucial outcome, in which the Commission failed to oversee in which shows that Ameren Missouri, the Respondent will jump through any deceptive practices to deceive not only the Commission, but to alter, change or reproduce an outcome favorable to them and extorting Ameren customers and none less, the Complainant.

Surrounding background Ameren Missouri in EC-2023-0395 submitted a DR request labeled as Exhibit D which was two separate pages. NO MPSC0027. On the second page of the bogus, fraudulent, altered document that was made upon Ameren's legal counsel, with the assistance of their Regulatory Department, they tried to make it look like it was a coding introduction made and labeled as a "senior software engineer."

There was no "senior software engineer" who put the coding indexes in. It was done by Banks Law LLC, Jermaine Grubbs and Aubrey Krcmar.

Line 2 of the coding detail Ameren forgets to add the "o" for to.

Line 6 for is blank in which Ameren Missouri failed to encode or embed into the coding index the number of installments, which would have been 12 installments and forgot to encode in their index the amount additional on top of bills which would have been \$210.00 per month. Failed to input these values into the index.

Line 7 of the coding detail in which Ameren Missouri failed to add "e" to failure.

Line 10 of the coding detail, Ameren introduces their email address as [www2.ameren.com](http://www2.ameren.com) Which is not only an invalid link. It is NOT the email address they use. If you look at the payment agreements Ameren Missouri sends, they come from the email address [DONOTReply@ameren.com](mailto:DONOTReply@ameren.com)

[www.ameren.com](http://www.ameren.com) would lead to their actual website, not a payment agreement, therefore it wouldn't be also Ameren's email address in return, as it is used for hosting their website and it isn't an email address, therefore if they inserted [www.ameren.com](http://www.ameren.com) or [www2.ameren.com](http://www2.ameren.com) it would not send an email or allow Ameren even to send an email because [www.ameren.com](http://www.ameren.com) is used for their website, not email purposes.

The fact that they would leave this many crucial details out is because Ameren got away with fraud, extortion, alteration, deceptive and are still to date using those deceptive, deceiving tactics.

Ameren Missouri is a business registered to do business in the State Of Missouri.

Terms and conditions of a business is to produce good working ethic and follow all laws, rules State and Federal Statutes.

This altered, fraudulent document, reproduced document that Ameren submitted as an exhibit and essentially got overlooked by the Staff of the Commission, Commissioners and the Regulatory Judge and the Complainant in EC-2023-0395 clearly shows that Ameren,

through any and all of their counsel, their Regulatory Department, their CEO, CFO and other members of their executive management and more importantly their Board Members, will go through any obstacle to defraud, deceive, and practices fraudulent practices with their business licenses and Articles Of Incorporation they filed within the State Of Missouri.

The submittal of this fraudulent document to pursue a favorable decision shows Ameren has failed to agree to the correct policies in engaging in the business practice in the State of Missouri.

Ameren Missouri has engaged in the practice of fraud.

Ameren Missouri has engaged in the practice of collusion.

Ameren Missouri has engaged in the deceptive business practices with the intent to deceive.

Ameren Missouri has engaged in extortion.

Ameren Missouri has engaged in theft, stealing, fraud buy transfer, theft of funds.

Complainant respectfully asks the Commission and the Regulatory Judge in EC-2024-0217 to file an Injunction in Cole County, Circuit Courts, file a Quo Warranto within the Missouri Secretary Of States Office barring Ameren Missouri and revoking Ameren Missouri's Articles of Incorporation from practicing business and ceasing operations immediately, until a further investigation is launched into the matter intently by not only the Commission, but the Staff of the Commission.

Further more based on this produced fraudulent document that Ameren Missouri used in EC-2023-0395, it paved the way for Ameren Missouri to extort the Complainant, Brett Felber in EC-2023-0395 out of not only \$ [REDACTED], but also additional expenses listed in earlier filings.

The Commission should issues an automatic Summary Judgment against Ameren Missouri and order Ameren Missouri return within 1 week of this filing the certified funds of \$ [REDACTED] to the Complainant for further committing fraud, deceptive business practices and extortion against , Brett Felber.

The Missouri Public Service Commission should file a report with the DOJ's Office showing the exhibited copy that Ameren Missouri produced in EC-2023-0395 and the exhibit labeled as NO MPSC 0027 showing the exact same collusion that Ameren Missouri propounded upon. Exhibit D

Complainant will be filing an immediate complaint within the Attorney General's Office to make the Attorney General aware of the fraudulent document that he received from Ameren Missouri, non less, also an item that the Commission, Commissioners, Staff of the Commission failed to accurately review to see the mistaken imbedded right in front of them and that this "agreement" Ameren says was instilled by their "software engineers."

This document proves that Ameren Missouri cannot be trusted as a business in the State of Missouri, but also proves that they most likely have done this to alter or perceive other decisions and pivotal outcomes in their favor that should have been ruled in favor of the Complainants.

Further, the Complainant asks the State Of Missouri or the Public Service Commission, Commissioners and Regulatory Judge in EC-2024-0217 to seek out to all counties or jurisdictions in which Ameren Missouri has business licenses and see that they are revoked immediately pending further investigation launched.

While the Commission is a body, they have the jurisdiction to oversee and they ensure Missourians that they are receiving not only fair rates, but also business practices to ensure the reliability of customer service to Missourians.

Complainant further more seeks that Ameren Missouri's legal counsel immediately resign or any officers, controllers , employees of Ameren that were engaged in the reproduction immediately resign from their positions before the Complainant files any additional legal recourse to have them immediately removed, or ceased from engaging in the practice of business in the State of Missouri.

With filing Articles of Incorporation and obtaining business licenses Ameren Missouri is required to follow all business laws, in which they haven't and Ameren Missouri must be removed from operating and operations should be immediately ceased.

The Commission should allow or file a motion or Injunction to see that a different utility provider is allowed to intercept all business articles, meters, lines, transformers, plants and a different utility provider that wishes to engage in proper practices in Missouri to provide reliable safe and fair billing practices and engage and abide by all laws within the State Of Missouri.
