## ORDER CANCELING DISCOVERY CONFERENCE

On July 12, 2023, the Commission issued its *Order Establishing Procedural Schedule*. The order set a Discovery Conference for March 12, 2024. However, the order also has the following provision:

Any party with a discovery disagreement or concern shall file a brief statement describing that disagreement or concern and identifying any other party involved no less than two (2) business days before a scheduled discovery conference. Such statement does not need to be a formal motion to compel. If no party files a brief statement of a discovery disagreement or concern, then the Regulatory Law Judge may cancel the scheduled discovery conference.

No party has filed a statement describing a discovery disagreement or concern and there are less than two business days before the March 12<sup>th</sup> scheduled discovery conference. Therefore, the Commission will cancel the discovery conference.

### THE COMMISSION ORDERS THAT:

1. The March 12, 2024, discovery conference is canceled.
2. This order is effective when issued.

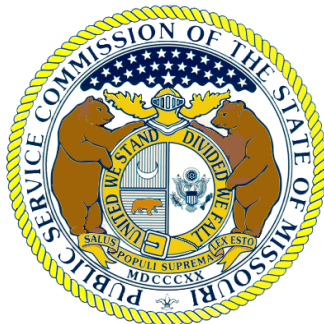
