Memo to the Missouri Public Service Commission

To the Missouri Public Service Commission, please keep EC-2023-0395 open until Judge Clark issues a re-hearing for this matter or sets a hearing to hear about the counterfeit documents that Ameren Missouri used in this matter that I have raised awareness of.

While there is a Statute of limitations in order to either appeal or request a re-hearing. I respectfully asked for a re-hearing after this matter was ruled on. However, there is no Statute of Limitations doesn't apply to documents that are counterfeit and altered documents and counterfeit documents that were used in production of committing fraud against a party and deceiving them out of additional money and money they shouldn't have lost.

Judge Clark needs to also answer to an Attorney Generals Complaint I filed against Ameren Missouri surrounding the document in question and that I have raised awareness about. The Attorney General file is CC-2024-03-001803.

In addition, Ameren Missouri needs to file a response to the Attorney General's Office surrounding the detail of the document as well.

If Judge Clark doesn't allow a re-hearing or doesn't issue a hearing resolving this document I have brought to their attention, which proves Ameren never sent an email with a payment date of May 18, 2023, as the email address they use for their hosting they listed on the document is www2.ameren.com.

www2.ameren.com is not a valid email address, therefore it would not have sent an email or would I have received an email from that address.

I know Ameren will most likely use the excuse that they meant to put www.ameren.com. Even if they used that, it wouldn't have sent and I never would have received an email, because it isn't an email address, as it is used for their website and hosting.

This document they submitted it typed up by their Regulatory Department Liaison, Aubrey Krcmar, prior counsel Jermaine Grubbs and co-counsel Eric Banks from Banks Law LLC.

I will also give them until the end of business today Tuesday to file a response to this letter as to why he allowed and knew Ameren submitted a counterfeit payment agreement.

Any correspondence emails that Ameren sends to customers such as payment agreements come from DONOTReply@ameren.com

Ameren Missouri is not even remotely close on the email address, because the copy Aubrey Krcmar and Ameren Missouri submitted on their behalf is a fake, fraudulent copy and a counterfeit copy.

In addition, it fails to address the payment agreement terms of 12 months and \$ [REDACTED] additional per month in which they indexed it as table border, cellpadding, cellspacing, color, wutable.

Ameren also needs to issue a response from their legal counsel by no later than the end of business today Tuesday March 12, 2024 or I will amend my filing with the Missouri

Department of Human Rights and the Charge of Discrimination I have filed against them, and I will present Amerens passing of a counterfeit document to the Cole County, Missouri Prosecuting Attorney's Office for deception of funds by fraud and fraudulent business practices.
