NOTICE OF FILING AND REQUEST FOR EXTENSION AND REQUEST FOR WAIVER

COMES NOW Missouri-American Water Company (MAWC), and, as its Notice of Filing and Request for Extension and Request for Waiver related to post-closing requirement 3f. states the following in support thereof to the Missouri Public Service Commission (Commission):

- 1. The Commission issued its Order Approving Transfer of Assets and Granting Certificate of Convenience and Necessity (Order) on November 8, 2023, with an Effective Date of December 8, 2023.
- 2. The closing contemplated by the Order was completed on December 13, 2023.
- 3. MAWC filed a Notice of Closing on December 14, 2023.
- 4. MAWC filed a Notice of Completion related to post-closing requirements 3.1, 3.0, 3.p. and 3.q. on February 12, 2024.
- 5. MAWC hereby provides the following documents that are attached and have been filed with the Commission, pursuant to the Order:
 - a. 3.f. 1. An agreement established with the golf course owner for land application.
 - b. 3.f. 3. MAWC's access agreement to the reservoir.

REQUEST FOR EXTENSION AND REQUEST FOR WAIVER

- 6. MAWC requests a ninety-day extension on the length of time MAWC has to complete the following items that were included in the Order.
 - a. Section 3.f. 2. A contract for treatment of wastewater from Pilot Knob.
- 7. MAWC and the City of Pilot Knob have reached an agreement in principle on the terms, but the agreement has not been fully executed, to date. MAWC will continue to move toward a fully executed document and will file one with the Commission when it is complete.
 - b. Section 3.f. 4. Emergency drinking water interconnection agreements with the City of Pilot Knob and the City of Arcadia, with the understanding that there is not a physical interconnection with the City of Arcadia.
- 8. MAWC and the City of Pilot Knob have reached an agreement in principle on the terms, but the agreement has not been fully executed, to date.
- 9. A water interconnection between MAWC and the City of Arcadia does not currently exist, and the documentation of any interconnect was removed from the Missouri Department of Natural Resources records. There is no longer any need for an interconnection agreement with the City of Arcadia and any agreement completed at this time would not accurately reflect those conditions and would not benefit either customer base. If a future interconnection is warranted, it will be in the form of a new capital project or emergency connection. If the need arises for such a connection, the cost and terms will need to be negotiated based on future circumstances.
- 10. MAWC seeks a ninety-day extension to complete only the first portion of this requirement to file an interconnection agreement with the City of Pilot Knob. MAWC further seeks a waiver of the requirement to provide an interconnection agreement with the City of Arcadia.

WHERFORE, MAWC respectfully requests that the Commission accept this Notice of

Filing and grant MAWC's Request for Extension and Request for Waiver, and any such further relief as it deem reasonable and just.
