ORDER CANCELING RECOMMENDATION

On March 7, 2024,¹ the Commission ordered Staff of the Commission (Staff) to file a Recommendation by March 13. On March 11, Staff filed a Status Report, Motion for Additional Time, and Suspension of Tariffs requesting such extension in order to complete discovery and allow sufficient time to analyze the acquired data from Spire and complete its investigation. Staff further requested an additional 90 days in which to complete its review and file its recommendation.

Considering the recently filed Staff Report, the Commission no longer requires a recommendation by March 13, and the Commission will cancel the order requiring such.

THE COMMISSION ORDERS THAT:

1. The order for Staff to file a Recommendation by March 13, 2024 is canceled.
2. Staff shall file a recommendation regarding Spire's revised tariff sheets no later than July 11, 2024.
