On March 9, 2024,¹ Brett Felber filed an amended complaint. On March 11, the Commission ordered Ameren’s response within thirty days or by April 8. Then on March 13, Mr. Felber filed a Motion to Reduce Ameren’s Time to Respond to only ten days or by March 19.

Accordingly, the Commission will order Ameren Missouri to file a response addressing whether it consents to reducing its time to respond and filing an answer by March 19.

THE COMMISSION ORDERS THAT:

1. No later than March 18, 2024, Ameren Missouri shall file a response addressing whether it consents to reducing its time to respond and filing an answer by March 19.
2. This order shall be effective when issued.
