## NOTICE OF DEFICIENCY

Issue Date: March 13, 2024

On March 11, 2024, Brett Felber, filed an application with the Commission requesting a change of electric supplier from Union Electric Company d/b/a Ameren Missouri to "Evergy". Both Evergy Missouri West, Inc. and Evergy Missouri Metro, Inc. are Missouri electric service providers regulated by the Commission. Neither Evergy Missouri Metro or West provide service on the eastern side of the state where the subject address is located.

Commission Rule 20 CSR 4240-3.140(1)(C) requires an application for a change of supplier state "[t]he name and address of the electrical supplier to which the applicant wishes to change[.]" To proceed with Felber's application, the Commission needs to know the specific electric service provider that Felber is seeking to have provide his electric service. "Evergy" is insufficient. Felber must clarify if he is seeking a change of service provider to Evergy Missouri Metro or Evergy Missouri West.

The Commission will not take action on Felber's application until this deficiency is corrected. This case may be dismissed in accordance with 20 CSR 4240-2.116(2) or (4) if the deficiency has not been cured, no action has occurred, or no continuance has been requested by June 11, 2024.
