ORDER GRANTING EXTENSION OF TIME

On March 13, 2024,¹ Evergy Metro, Inc. d/b/a Evergy Missouri Metro, and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (collectively, “Evergy”) and the Staff of the Commission (Staff) filed a *Joint Motion for Extension of Time* (Motion) regarding the filing of briefs. Initial briefs are currently due March 15, and reply briefs are due April 1.

The Motion explains that Evergy and Staff continue to have productive settlement discussions and requests an extension for the filing of initial briefs to March 22. The Motion also sets forth that the Office of the Public Counsel and the Midwest Energy Consumers Group do not oppose the Motion.

The Commission finds the request reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. The Motion is granted. Initial briefs shall be filed no later than March 22. Reply briefs shall be filed no later than April 8.
