## **MOTION TO CONSOLIDATE**

**COMES NOW** Liberty Utilities (Missouri Water) LLC d/b/a Liberty ("Liberty") and for its *Motion to Consolidate* states as follows to the Missouri Public Service Commission ("Commission"):

- 1. On March 13, 2024, Liberty filed tariff sheets and direct testimony to initiate general rate case proceedings. Liberty seeks an increase in its water and wastewater (sewer) rates and to unify the terms of service and consolidate rates statewide. The cases were assigned Case Nos. WR-2024-0104 and SR-2024-0105.
- 2. The subject water and wastewater operations are owned and operated by the same entity (Liberty) and have common offices, personnel, and overheads.
- 3. Accordingly, there are common questions of law and fact in the above-referenced cases, and consolidation would be administratively expedient in that it would simplify requesting discovery and the filings to be made by Liberty and the parties to these matters. Previous cases of this nature have been consolidated for the ease of filings and discovery. The Commission has stated that Rule 20 CSR 4240-2.110(3) allows the Commission to consolidate cases with related questions of law or fact.<sup>1</sup>

4. Thus, Liberty requests the Commission consolidate these cases, designating WR-2024-0104 as the lead case.

WHEREFORE, Liberty requests the Commission issue an order consolidating Case Nos. WR-2024-0104 and SR-2024-0105, designating Case No. WR-2024-0104 as the lead case. Liberty requests such further and other relief as is just and proper in the circumstances.
