The tariff sheets bear an issue date of March 13, 2024, and a proposed effective date of April 12, 2024. The P.S.C. MO No. 22 tariff book is designed to replace and consolidate Liberty's current P.S.C. MO Nos. 14, 16, 17, 18, 20, and 21 water tariff books. The P.S.C. MO No. 23 tariff book is designed to replace and consolidate Liberty's current P.S.C. MO Nos. 13, 15, and 19 sewer tariff books.

Liberty's Minimum Filing Requirements, as required by Commission Rule 20 CSR 4240-3.030(3)(B), are found in the Direct Testimony of Brooke Prier.

The purpose of these filings is to implement a general rate increase for water and wastewater service provided by Liberty. The revised rates are designed to produce an additional \$7,990,089 in annual water revenues and an additional \$75,178 in annual sewer revenues (excluding gross receipts and sales taxes). Individual rate changes proposed by the Company differ from water to wastewater and by service area because of the variety of rates that exist today, as explained in the Direct Testimonies of Antonio D. Penna Jr. and Thomas O'Neill.
