ORDER GRANTING APPLICATION TO INTERVENE

On January 17, 2024, Spire Missouri Inc. d/b/a Spire filed an application pursuant to Sections 393.1009 to 393.1015, RSMo, and Commission Rules 20 CSR 4240-2.060, 2.080, and 3.265, requesting that the Commission authorize changes to the Spire's Infrastructure System Replacement Surcharges (ISRS).

The Commission directed notice and set a deadline of February 16, 2024, for applications to intervene. The Midwest Energy Consumers Group (MECG) filed a timely application to intervene. MECG's application states that it is an incorporated entity representing the interests of large commercial and industrial users of electricity, water, and natural gas throughout the State of Missouri, including the area served by Spire.

More than ten days have passed since the application was filed and no one has responded. After considering the unopposed application to intervene, the Commission finds that MECG has an interest which is different from that of the general public and allowing it to intervene will serve the public interest. Therefore, in accordance with Commission Rule 20 CSR 4240-2.075(3), the Commission will grant the application to intervene.

THE COMMISSION ORDERS THAT:

- 1. The application to intervene of the Midwest Energy Consumers Group is granted.
