To the Prosecuting Attorney's Office.

Dear, Prosecuting Attorney. Attached in this packet is a long list of items that as of date Ameren Missouri utility company has failed to rectify. Ameren Missouri out of their regulatory office in Jefferson City, Missouri. You will see the attached document enclosed which not only shows a bogus email address attached in which Ameren Missouri claims is the external hosting address, but under the PAG terms of the agreement, they aren't even remotely close to the terms.

This document was used to extort me out of \$ [REDACTED], and in addition there is an audio recording that is also on a thumb drive for you to listen and your convenience and you will see that the Regulatory Division of Ameren Missouri changed the name of the coding way to make it look like a May 18, 2023 and in actuality the original sourcing of the document encrypted is from April of 2023. Ameren's Regulatory Department altered the way format name.

In addition, I have enclosed a second thumb drive which will include the video of Ameren Missouri's technicians committing property damage to the premises in which they have failed to rectify as well.

I have given Ameren an enormous amount of time to remedy and repair and answer the counterfeit document and they offer excuses or simply fail to respond.

As early as March 13, 2024, Ameren's legal counsel stated in an email, that she would reach out to me to inform me that she would be following up in response when she came back to her office on Thursday March 14, 2024. Even though I was exhausted and tired of excuses I gave the demand of by 5 pm on Thursday March 14, 2024. I even sent a reminder to her and the counsel attached. Of course as usual, they lied. There was no phone call or email message back.

I am tired of exhausting options and flat out have crafted illegal counterfeit document to extort me out of not only the \$ [REDACTED], but also the property damage that they failed to rectify, along with the generator, gas maintenance, oil, spoilage of food, loss of income, etc.

Attached are copies of the email correspondence with Ameren's new legal counsel.

At this point they are criminally extorting me and I am done given Ameren Missouri chances. Tired of it.

Enclosed in this packet is a copy of my legal counsel's information who I have retained to seek prosecution on this matter. I am tired of excuses, I want answers, I doubt they will give you answers. They were habitual liars in the complaint filed with the Missouri Public Service Commission and they have altered altered numerous documents and audio's to try and match.

I will cooperate in any part of the investigation process and who this needs to be attention to. I don't believe that Ameren Missouri has the necessary means to rectify the situation, and the only way which is the last resort in which I really don't want to do but to Prosecute them.

I want Ameren Missouri and the employees and lawyers that engaged in this counterfeit document and altering the audio clip Prosecuted, fined and punished. In addition, I also want

my money back in return. I was extorted and they have the necessary capability to continue this.

I don't believe Ameren Missouri will stop their criminal acts until they are prosecuted to the fullest extent of the law. In addition, I'm seeking that their Articles of Incorporation are revoked and Ameren cease from conducting business, until they reimburse all monies.

I appreciate your time to overview this packet and again looking forward to the truth of the matter coming out.
