**ORDER CLARIFYING MARCH 13<sup>th</sup> ORDER**

On January 25, 2024,<sup>1</sup> Brett Felber filed a complaint against Union Electric Company d/b/a Ameren Missouri to which Ameren filed an answer on February 23. Mr. Felber then filed an amended complaint on March 9. On March 11, Staff of the Commission (Staff) filed its investigative report regarding the original complaint. On the same day, the Commission ordered Ameren to file an answer to the amended complaint by April 8 and for Staff to file its investigative report regarding the amended complaint by April 23. On March 15, Staff filed a motion for clarification regarding similarities in the amended complaint to issues litigated in other matters before the Commission.<sup>2</sup>

Accordingly, the Commission will order Staff to investigate and file a report for not previously litigated issues.
