On March 12, 2024, Missouri-American Water Company (MAWC) filed a request for a 90-day extension to file a contract for wastewater treatment from Pilot Knob. MAWC further seeks a waiver of the requirement to provide an interconnection agreement with the City of Arcadia because MAWC and the City of Arcadia are not interconnected. The Staff of the Commission responded on March 15, 2024, stating it does not object to MAWC's requests. No other party responded.

The Commission finds MAWC's requests reasonable, and will grant them.

THE COMMISSION ORDERS THAT:

1. MAWC's March 12, 2024 request for a 90-day extension and a waiver are granted.
