- 1. MAWC closed the transaction that is the subject of the Commission's *Order Granting Certificate of Convenience and Necessity* on April 17, 2019.
- 2. Concurrently, with the filing of this Motion, MAWC has filed sewer tariff sheets consistent with the Commission's *Order Granting Certificate of Convenience and Necessity*. The subject tariff sheets are intended to clarify the rates, rules and regulations that will apply to the subject customers on a going-forward basis.

WHEREFORE, for the foregoing reasons, MAWC respectfully requests the Commission grant this Motion for Expedited Treatment and approve MAWC's proposed tariff sheets identified by Tracking No. YS-2019-0209, to be effective as soon as the Commission has the opportunity to address this matter.
