ORDER SUSPENDING TARIFFS

Effective Date: March 21, 2024

On March 11, 2024, the Staff of the Commission (Staff) filed a Motion to Suspend Tariffs and Motion for Additional Time (Motion). The above-referenced tariff sheets were filed on March 6, 2024, and they each bear an effective date of April 5, 2024.

Staff explains that these tariff sheets, which are to change Spire Missouri Inc. d/b/a Spire’s transportation tariff language for gas service, contain multiple tariff sheets that were at issue in the previous general rate case. Thus, Staff asks for the Commission to suspend the tariff sheets¹ to allow time for discovery and to allow time to analyze the acquired data and information and complete its investigation. No responses were received.

The Commission finds Staff’s Motion reasonable. Therefore, the Commission will suspend the tariff sheets.

¹ Staff incorrectly listed the tariffs as including “Original Sheets 9 through 9.31”, those tariff sheets should have said “Second Revised Sheets No. 9 through 9.4, Cancelling First Revised Sheets No. 9 through 9.4, First Revised Sheets No. 9.5 through 9.11, Cancelling Original Sheets No. 9.5 through 9.11, Second Revised Sheet No. 9.12, Cancelling First Revised Sheet No. 9.12, First Revised Sheets No. 9.13 through 9.29, Cancelling Original Sheets No. 9.13 through 9.29, and Original Sheets No. 9.30 through 9.31”. *Staff’s Status Report, Motion for Additional Time and Suspension of Tariffs*, (filed March 11), p. 2.

THE COMMISSION ORDERS THAT:

1. The following tariff sheets filed by Spire Missouri Inc. d/b/a Spire Missouri on March 6, 2024, and assigned Tracking No. JG-2024-0124 are suspended for 120 days until August 3, 2024, or until otherwise ordered by the Commission.
2. This order shall be effective when issued.
